17. Terms of payment:

- For foreign suppliers: unconfirmed (or confirmed), irrevocable, divisible, documentary letter of credit opened by the Buyer on behalf of the Supplier in accordance with the "Uniform Customs and Practice for Documentary Credits" (ICC publication #600) Paris, published 2007. Letter of credit is opened within seven business days after signing the contract and transfer of foreign currency to the account of Buyer after converting funds. Terms of the letter of credit 210 days from the date of its complement up to 100%. Cost of letter of credit is covered by the funds of Supplier.

Under the terms of mounting, installation and operation of equipment the standard warranty period shall not be less than 12 months (unless otherwise provided by the terms of requirements specification) from the time of acceptance tests, but not more than 18 months from the date of delivery of the last batch of goods under the relevant tranche on delivery CIP -Tashkent (foreign suppliers) or on delivery to the Buyer's warehouse (local suppliers).

Supplier shall correct all the equipment and software failure within one month from the date of receiving notification on fault or failure. Generally, the warranty services should be performed in Tashkent or placement of equipment.

22. Required to have service center and/or authorized partner in the Republic of Uzbekistan to provide warranty and post-warranty service, if it's stipulated by requirements specification.

At the same time, in order to confirm the presence of service center and/or the authorized partner in Uzbekistan for after-sales service, the Applicant must provide information on the availability of service centers in the Republic of Uzbekistan (or authorized partner in the Republic of Uzbekistan) to provide warranty and postwarranty service (the list and addresses of service centers, authorized copies of contracts with partners).

23. As part of the tender offer (at their own expense), the Supplier (the winner of the tender) must provide services on starting-up and adjustment of the equipment and training of the specialists and experts of the Customer after installation of the equipment in Tashkent, if it's prescribed by requirements specification.

In this case, the Supplier (winner of the tender) must send a specialist for training to Tashkent within 10 days after receiving the formal proposal from the Buyer.

- 24. Winner of the tender must provide (if necessary in accordance with the code of goods GN FEA) preshipment inspection of goods, with the assistance of an independent inspection company, duly accredited in Uzbekistan. In this case, the cost of a pre-shipment inspection shall be borne by the Supplier.
